C/FO SHOP TALK #42 cost 59¢ apiece to send out, and all accounts have had that much deducted from them. This issue is thicker, so it will doubtlessly cost more to mail.

The C/FO has been getting a lot of publicity in Japan at present. There are writeups on the club and on our bulletin in the October 1984 MY ANIME and the November and December issues of ANIMAGE. The November MY ANIME has a 4-page report on the 1984 Worldcon, which is not directly C/FO-related but emphasizes that there are a lot of fans of Japanese animation in America. Now it looks like ANIMAGE wants to emphasize the American-Japanimation connection on a regular basis. This is likely to bring us into greater contact with Japanese fandom. And that makes it more important than ever that we get our act together and establish just what the C/FO is and what it offers.

Here is the latest chapter roster. This was published last week, and it's already out of date. Susan Johnson has just reported, "... this is to inform you that C/FO Ontario is no longer functioning as a chapter, and therefore should be dropped from the lists. If anyone in the future decides to revive it, or start a different chapter, you will be notified." (That's too bad. Might we ask what happened, Susan?) I hope that this roster will also become "outdated" soon in the sense that we will get information on the C/FO-Central Florida Operation and the others, so they can be added to the list. Since those chapters haven't replied themselves, can anybody else supply the appropriate information about them?

This chapter roster is designed to go with the C/FO's general information sheet. But where the information sheet should be attractively designed and intended to last for a long time, this chapter roster is designed to be easily updated. We now have well over a dozen chapters, and it seems as though the roster hardly lasts a month before there's at least one change of address or meeting day-of-the-month. This roster can also be printed in small runs on any cheap photocopy machine, so that when it is

updated we won't have lots of copies of the old edition to throw away -- whereas when we do finalize the general information sheet, we should have lots of copies printed to last us a long time.

This chapter roster isn't "official". It's my design, which I created because we needed a chapter roster and there isn't any other. This just shows one way that it can be done. If anybody has any suggestions for improvements, let's have them. If there's a better design that can replace this entirely, let's get it into use. The important thing is that the C/FO have some kind of chapter roster, because we do get asked (for example, by ANIMAGE), "How big is the C/FO; how many members and chapters does it have; what cities does it have meetings in?" This roster, which I've been using for some time, is one that we can all use. I can send copies to any chapter or individual who wants them for, say, publicity at a local convention. Or I can send a master copy which you can use to print your own supplies; or you can just type your own copy of this roster in about 20 minutes! If chapters will send in news of any changes in their routines, I'll announce these updates in SHOP TALK every month even if I don't print a full revised roster each time. This will enable all of us to be current on where all of our chapters are all the time. This is information that every C/FOer ought to have handy to promote the club.

This SHOP TALK includes some recent submissions to the club archives. One is an excellent information sheet that the C/FO-New York has just created. This is a superb job of illustrative montage. How many chapters do have their own information sheets? Are there any chapters that would like to have one but don't have any local talent to design one? There may be C/FOers elsewhere in the club who would be glad to help out, if they know about it.

Here are the current issues of a couple of chapter bulletins. Do you want to see these local bulletins in SHOP TALK regularly? Let me know -- there's no point in running up SHOP TALK's postage bill with material that we aren't interested in.

Damon Foster's letter in this issue is undated, but it was postmarked 20 August. Since it was addressed to me personally rather than to SHOP TALK, it's only now occured to me that its phrasing implies that Foster wants his statement to be made to the club at large. (To be honest, this was in a stack of non-urgent personal mail that piled up while I was working on the 1984 Worldcon and which I'm still catching up on.) I'll send copies of this SHOP TALK at my expense to both Foster and to the C/FO-Hayward's Mark D. Keller, in case either of them want to follow up on this.

This brings up the point of C/FO chapter participation in s-f conventions. This is becoming more and more common. The C/FO-Cleveland is running regular video rooms in Cleveland-area conventions. The C/FO-Los Angeles just ran a very successful video room at Loscon II in Pasadena, Calif., over the Thanksgiving holiday weekend. The room, run by Jeff Roady, was supposed to be for only one day of the three-day convention; but it was so popular that the Con Committee extended it for a second full day. The C/FO-San Diego is scheduled to run a video room at ConQuistador II in that city, on 1 - 3 March 1985. Should we try to compile a calendar of forthcoming conventions at which there will be C/FO-run video rooms? A C/FOer who lives 400 or 500 miles from a chapter might not be able to attend that chapter's regular meetings, but he/she might consider it worthwhile to attend a convention if he/she learns that there'll be a C/FO program there. Foster's letter raises another point (which may or may not be pertinent to this particular incident): should we try to get more reports on the successful video rooms, with an emphasis on why they were successful, for the benefit of chapters without experience so that they can avoid mistakes when they plan their first convention programs?



The quick and dirty heading that I did for SHOPTALK was just a suggestion, and I didn't do it as a finish because I was concerned that it would not be accepted or approved of by the people involved. Ann Nichols has objected to it on the basis that it says it is "The OFFICIAL voice of interest in the C/FO." I chose that wording deliberately, partly as a joke, and partly because I have noticed in so many clubs and organizations, most of the members join but do not participate. They do not VOICE their INTEREST. I'm the same way. I belong to lots of organizations simply because I believe in what they're doing, and I want to be a small part of it, but I haven't the TIME to actively participate. There is always only a small cadre of people, sometimes less than one per-cent of the membership who actually say anything or get things done. The rest of the membership just sits back and watches, if that.

I feel that the SHOPTALK logo should stand, just the way it is, because we who participate in it are just about as official as anything else in this club, and I disagree with Ann Nichols when she expresses the opinion that the MAJORITY of ALL of the club members must vote one way on an issue to decide it. All that is needed in my opinion is that the majority of those members WHO VOTE agree on an issue to decide it, EVEN IF ONLY THREE, or even ONE member votes. That's the way the elections for President of the United States work, and if we are to claim that our club is run by the voting membership, we need operate in no different a manner.

And so I say, let the logo stand, just the way it is. If any member doesn't like it, why, then, they are invited to participate in the club by voicing their opinion in SHOPTALK, just like everyone else. SHOPTALK isn't the official VOICE of the C/FO; that's the membership, well, at least the voting membership. SHOPTALK is the official voice of INTEREST in the C/FO, not quite the same thing. And since SHOPTALK is performing the function that it always has, I maintain that the numbering continue in sequence issue by issue. In a way, SHOPTALK is a magazine devoted to the C/FO club itself, rather than to fan-talk about cartoons, and addresses matters which can then later be put to the membership, rather like the Congressional Record written by non-elected as well as elected members. It's sort of like a town meeting in print. I am very suspicious of people who come off as well-meaning who want to shut people up, whoever they are. I was not happy that some people wanted to eliminate SHOPTALK. Participating in SHOPTALK is a very real part of the enjoyment available to all members of the C/FO, and we should work to EXPAND, not CURTAIL activities in the club.

Honorable Everyone:

Mike Sherman: The vote to raise the club dues was almost unanimous in favor of the raise. Dues should be sent to the club Secretary. ## The prospect of getting those "Le Roi Leo" episodes don't look good. The fan who has them doesn't want to be bothered with tape trading at the moment; "at the moment" has lasted for a couple of years now. However, I've been told by several fans recently that the "Kimba" sequel has been dubbed into English and is currently being broadcast under the title "Leo the Lion" on the Christian Broadcasting Network (CBN), the channel that commissioned "The Flying House" and "SuperBook" from Tatsunoko Pro. If this is true, you may be able to get copies from C/FOers who can get the CBN casts. ## Congratulations to Jean Dewey. Regional s-f conventions are now beginning to list "Japanese animation" on their advertising as a standard attraction along with their Art Show and their Dealers' Room. I think that this is an evolution in fandom that the C/FO can take full credit for, thanks to the efforts of chapters like yours.

Barb Edmunds: Len Moffatt was the mad murderer who impaled me with a Hugo rocket at the beginning of the Worldcon. However, you'll have to read the mystery if you want to know why he killed me. I.e., the Worldcon still has copies of its fannish murder mystery for sale: Fandom Is a Way of Death, by Bill Warren & Allan Rothstein, with a full-page illustration by Charlie Jackson of my gory corpse. If anybody wants it or any of the other 1984 Worldcon souvenirs (T-shirt, cap, etc.), let me know and I'll send a price list. ## Congratulations for your good work in connecting so many penpals. Are you doing this as a personal project, or as a C/FO project? If it's a C/FO project, then I think you should be entitled to reimbursement from the club treasury. However, I believe that this brings up an old question that we never did get settled: who decides what is a legitimate C/FO project and what's not? We want to encourage individual initiative. On the other hand, we don't want the situation where some member decides that the C/FO needs more publicity, so he has a full-color advertisement printed for us and presents us with a \$1,000 bill without checking with anybody first. That sort of thing has happened to some clubs. ## No, I did not say that I'd send a rough copy of SHOP TALK to Ann for her views. Where did you get that idea? I said that I'd notify her that SHOP TALK was starting up again so that she could participate if she wanted to. I was very emphatic on the point that nobody gets free copies of SHOP TALK any more, and that I don't intend to pay anybody's postage out of my own pocket. I may treat somebody to a sample copy, or send somebody an individual issue for a special reason; but if somebody is interested enough in SHOP TALK to want it regularly, he or she should be willing to pay for it regularly. Besides, what is a "rough copy" of SHOP TALK? I try to print each letter as soon as it arrives, but there isn't any lag between the time that I print the final contribution and the time that I collate the issue and mail it out. The only way that I could send a rough copy before the final copy is ready would be to send separate photocopies of each letter as it's received. What would be the purpose of that? ## I have to confess that I sometimes fall weeks behind in answering mail, and I never do get around to some letters. There's just not enough time to answer it all. It's a matter of personal priorities. I'd rather work on projects like

the Worldcon, and serve as Secretary for the C/FO-Los Angeles, and publish this SHOP TALK, and participate in apas such as APATOONS (for animation fans) and ROWRBRAZZLE (for funny-animal fans), and write reviews & articles about s-f & comics & animation, than I would take on yet another pen-pal. That's why I pass on a lot of personal mail to me from fans who're looking for pen-pals. It's very important that these letters are answered by somebody, so I appreciate very much that your personal taste in fanac runs along these lines.

Ann Nichols: Sorry that you consider my report on the SHOP TALK vote too vague. As I said last issue, I considered the whole nature of the votes held at the L.A.con open meeting to be unofficial straw votes, since the meeting didn't have the authority to pass anything binding upon the whole club. Therefore, when the majority of the hands in the room went up on the vote to resume SHOP TALK, I didn't see any need to count the exact number of hands. Frankly, I think there were a lot more people at that meeting than the 49 who signed the roster; that's why I reported that "49 people signed the roster" rather than saying that the attendance was 49. I asked a couple of times during the meeting if everybody was signing the roster, and the answer was always that everybody was. But the room was set up with seating for 60 people (not counting those at the head table), and the room was pretty packed for most of the two-hour meeting, until just before the end when people began leaving to get to program events starting at noon. And some people did leave and others arrive during the two-hour meeting. The vote to resume SHOP TALK was held around the middle of the meeting, when the room was still quite full. I would estimate that the vote in favor of SHOP TALK was around 35 or 40 -- which was why I was rather sardonic in my comment in SHOP TALK #41 about the number of members who voted that the C/FO needed SHOP TALK being considerably larger than the number of members who actually signed up to do something about starting SHOP TALK again. Whoever told you that only 15 people were left when the SHOP TALK vote came up may have gotten confused by the fact that this was the number of people left after the meeting adjourned, which was when I signed up the members who wanted to get SHOP TALK. I hope that some of the others who are currently getting SHOP TALK who were at that meeting will state their impressions of that vote. ## As to your comments about the "official" and "unofficial" SHOP TALK, I'm not sure what you're talking about. If you want to get technical, the C/FO doesn't have any "official" publications. Until we get a Constitution, we can either say that we don't know what's official and what's not, or we can say that nothing is official. If I understand correctly, you based your postponement of the 1984 club elections -- which I feel was definitely illegal -- on the rationale that the rule that elections would be held at the end of each year so that the new officers would be installed on January 1st, was never approved by a formal vote of the entire membership. It had simply been stated that this seemed like a good idea which we would follow in the future. Therefore you weren't actually breaking any formal club law when you extended your term of office and changed the voting procedure. Well, the club similarly never formally voted to create an official bulletin, an official membership roster, etc. If I may be pardoned for patting myself on the back, I was the one who said that I thought the club should have a monthly bulletin, and a membership directory twice a year, and a SHOP TALK (originally twice a month; later monthly). And I started them. And the reaction ranged from an informal approval to no comment. Nobody ever formally approved any of these. The only negative comment was about SHOP TALK, and that was primarily based on the mistaken notion that SHOP TALK was an elitist publication which the "ordinary members" weren't allowed to get. There was talk at the beginning (including some from me) about limiting SHOP TALK's circulation to the club's officers, but in fact any member who ever asked to get SHOP TALK was put on the mailing list. So, with this background, you can't say that SHOP TALK is a less-official club publication than any other C/FO publication just because the entire club didn't vote on it. To cite another example, when Jane McGuire announced in mid-1982 that she was starting a C/FO Translators' Guild, our reaction was, "Congratulations! Go to it!" -- not, "You can't call yourself the official Translators' Guild because you didn't have the whole club vote on it first." The attitude of both the general membership and of the officers was that her Guild was

as official as anything else in the C/FO. SHOP TALK is entitled to the same consideration. As far as I'm concerned, the vote on SHOP TALK at the L.A.con was irrelevant because SHOP TALK was never officially discontinued before. We just had a period of a year when nobody was contributing to SHOP TALK. What was really important about the L.A.con meeting was that it got members to contribute to SHOP TALK once again so that its publication could resume. So, I agree with you to the extent that it's pompous to call SHOP TALK an official club publication. I myself would object to Wendell's heading if it were serious. But it seems obvious to me that the heading is in fact a parody of such pompousness -- the "TM" next to SHOP TALK should give that away. In that light, I see nothing wrong with the heading. And I would object to calling SHOP TALK an unofficial publication, unless we also start labelling the bulletin "the unofficial C/FO bulletin"; the membership directory "the unofficial membership directory", etc. ## No, I didn't contact Wendell or Michael when SHOP TALK #41 was published to confirm that they still wanted their letters printed. I just assumed that they would. A couple of months after SHOP TALK #41 was originally due last year, when it was evident that there was not enough interest at the time to continue SHOP TALK, Wendell wrote to tell me to turn over the \$10.00 he'd sent for his SHOP TALK account to the general treasury, to support Kurt's new bulletin instead. I did so; and when SHOP TALK started again this October, I donated \$10.00 myself to Wendell's SHOP TALK account. I didn't hear from Michael so I just held onto his \$5.00 until SHOP TALK started again. Because I was sure that SHOP TALK would resume, once the club realized how much it was needed. ## If I'd read Fred Cain's letter aloud at the L.A.con open meeting, it would've brought the fastmoving meeting to a dead halt. Everybody could see that by the number of pages in the letter as I held it up. Besides, the meeting had just voted to resume SHOP TALK to solve the problem of providing a forum for discussions about improving the club, and when I got up to say, "While we're on that subject, I have a letter of suggestions for the club from a member who's not here, " the reaction was, "That'll be great to start off SHOP TALK with!" I felt that it would have been too pushy to insist, "No, I'm going to read it aloud to you, " especially if I was going to print it in SHOP TALK anyway. ## Well, I can understand the vote to transfer the C/FO's traditional Worldcon open meeting to the NASFiC in 1985. The NASFiC will probably have the C/FO attendance that the Worldcon usually has, while there'll probably be only three or four C/FO members at the Worldcon in Melbourne. So that vote made sense. I don't understand why Dan Davis wanted to transfer the Worldcon open meeting to the San Diego Comic-Con, since everybody knew that the C/FO has a separate Comic-Con open meeting already. It was pretty obvious that the meeting had made up its mind to support Austin, so I guess that everybody figured that it'd be faster to let Dan call his vote and then vote it down, rather than to spend time arguing against the idea in debate. But I may be projecting my own attitudes on the other attendees by that statement. ## If Wendell wants to remove the "official" from his logo, or to rephrase the subtitle completely, that's fine with me. I would object to labeling SHOP TALK "the unofficial voice of interest in the C/FO", but I don't mind simplifying it to "the voice of interest in the C/FO". But I'll leave that up to Wendell since it's his heading. ## It's true that the new C/FO bulletin is a lot more work than the old one on an issue-to-issue basis. But the old, 12-page bulletin came out every month, whereas we've only had eight issues of the new, 32-page bulletin in a 24month period, or approximately one issue every three months. On that basis, it's not a lot more work after all. In some respects it should be less work; you only have to mix the photographic chemicals, ink up the press, once instead of three times. I think that the new bulletin is good enough that most members wouldn't mind having it officially published only four times instead of monthly, if they felt that they could reliably expect it on that schedule. It's the uncertainty that's hurting club morale. Let's face it: the C/FO did publish a monthly bulletin from 1977 to the end of 1982. During most of that time it was only one or two pages, but it did come out regularly -- the only issue that it missed was July 1981, when Jim Zepeda was supposed to take over as editor but didn't, and Vince Richards stepped in immediately to replace him. That bulletin, as small as it was, was enough to attract a lot of members. From 1979 through 1982 we

announced in flyers that a \$10.00 annual membership would get the member twelve monthly bulletins, and we delivered on that promise. When Kurt Black was chosen to become the new editor beginning in 1983, it was because he promised to reliably continue the C/FO monthly bulletin. (My emphasis.) When he announced that he was going to expand it to 32 pages, he continued to promise a monthly bulletin for -- how long? How long was it until it was admitted that we wouldn't get a 32-page issue every month, but we would get eight or ten issues a year, or seven, or six ... In fact, we've only averaged four issues a year. At the same time, because the bulletin's frequency was never formally reduced, we've continued to use the publicity flyers promising twelve issues a year until it got too embarrassing to do so. This creates a very bad feeling all around. Members don't know what they're actually entitled to for their fees; there's a feeling that the rules are being changed on them without consulting them; a member who hasn't gotten a bulletin in a couple of months doesn't know whether the bulletin itself has been delayed or whether his copy was lost in the mail and he should ask for another. This situation can be improved if we set some rules and stick to them. We've had two years to experiment with the 32-page issue now, and it looks like four issues a year is what we can manage. The magazine is good enough that that's not bad. There are lots of clubs that don't produce four issues as good as Kurt's a year. I think that most C/FOers will accept four issues of this quality for \$15.00, if they know that that's what they're supposed to get and if they do get it on what seems to be a regular, reliable schedule. (I personally think that it would be better if we had a slightly thinner bulletin a bit more frequently -- say, six 20- or 24-page issues a year -- but four 32-page issues will work.) That way we can start advertising again what the C/FO is supposed to deliver for a membership, without any uncertainty. I would suspect that it'll make things easier for the Blacks and for Bill Wilson if they can settle into a regular schedule of having to produce only four issues a year, instead of trying to produce as many issues a year as they can. This is a policy that could probably be put into effect almost immediately. Comments?

It's just occurred to me that we probably can't update the C/FO flyer until Kurt circulates his ballot with the bulletin #10 and we find out what the result is. If the result is that the Blacks give up the bulletin after issue #12, will the new editor continue the same kind of bulletin?

While we're waiting to find that out, here are some other questions to be answered. Should the C/FO have a permanent address in addition to that of the Secretary of the moment? If so, should it continue to be the 401 South La Brea Avenue, Inglewood, California address? If not, where should it be? Should we continue to plan on printing a Membership Directory every six months? Would one per year be enough? Apparently the membership cards are all gone; should we have new ones printed of the same design, or should we change the design? (The old cards just had lines for the signatures of the member and of the Secretary. Some members suggested that a third line be added to include the dates covered by the membership, so that it would be obvious when the membership expired. The old cards were also printed in two colors on high-quality stock and were rather expensive. It would be faster and less work if we just have more cards of the same design printed, but we might be able to design an improved, cheaper card if we want to save money -- but who will design it?)

And these characters may later be worked together into one or more stories, in collaboration or contest ... Now, that should be a reason or two for everybody to get off their lazy little duffs..! More than one character may be submitted; but only one prize will be awarded to any member... All copies must be here at my place by (- (?) -) 1985.. If you don't get the dough (and you might-!) It only costs 20d to try; and you still get your work displayed with credit .. My decisions are final 'cause I'm running this do-it-yourself-disaster solo to try and get this sleeping elephant we call a Club, on its' feet all by my lonesome (I've given up on Club bureaucracy).. and I'm too poor to give prizes to everyone (though I'm sure yours deserved one -and I'll try to answer all submissions).. Work can be sloppy or amatuerish, but not 'gross' -- (that gets 'File- 13'd)! (Copyright forms aren't as difficult as they look.. ignore the 'legalese'; -fill out the blanks..include one complete copy of your work (a short 'strip' for a comic-idea will be sufficent)..comic-art goes into 'visual' publications class -check at the Federal Information Service (try the phonebook), they'll help you.. -and when I got my first series copyrighted in 1980. it cost a fee of -if my memory fails me properly- \$10.00 (-but don't take my word for it).. A copyright is now good for your life + ten years ... Other people may emulate it -as 'fan' art & friends- but anything involving a real cash return (we're not talking fanzines..) -or used in a manner without your permission or against your liking; must either give you your fair due and/or cease and desist!.. Anybody who tries to pirate a copyrighted work-- if they ask: 'who's your big brother?...' -You can say you've got a big Uncle who says so- named 'Sam!' .. (!!- oops!)

Finally, in this contest; artwork of already-existing characters will be acceptable... You want to do Speed Racer; Astro Boy; Felix the Cat; Elfquest; Moonchild; Mighty Sampson; Fanta; Betty Boop; Kimba; or Major Hoople-- go ahead. -But, originality will count for a lot!.. 

Editorial: Although no actual timetable has been set yet for the club elections, there will be an announcement in the 9th issue (already sent in for printing) calling for platforms from those who plan to run.

Barb Edmunds: I've talked to the chapter rep who wanted to have me impeached. over the dues increase. He says he doesn't feel that way anymore, which is nice to know.

Fred Patten: How nice of you to volunteer to update the chapter roster, especial-

ly when you don't need to do it anymore.

I'd like to know why you wrote that we should "...settle for being just a happy but dumb fan club," Being an officer in a fan club is not as prestigious as being an officer of C/FO Inc. would have been, but your evident disappointment is no reason to insult the rest of us.

I talked with Kurt Black about what you wrote about why the C/FO couldn't produce a calendar, and he says there's no reason why we couldn't have one for 1986 if we got started very early in 1985. The money is not as much of a problem now as it would have been then because the treasury is healthier.

When you question how many members would want to buy a C/FO calendar, are you questioning their interest in a calendar of club mascots or the ability of our

members to produce a calendar that would interest buyers?

Weren't you the one who originally had the membership cards printed? Are they all gone? Have you passed on the information on how to get more done to anyone?

You hadn't told me (until I asked you) that you'd been having trouble getting membership information from Alex Potter. I called her up and asked why she hadn't given it to you. She said she'd figured you could get the information from Harold and that would save her 20¢. As for why she doesn't answer your letters; she says she doesn't like you, she's sick of you talking behind her back, she sees no reason to write to such a person, and I may quote her on that.

Yes, it would be nice to have the bulletin coming out on a regular schedule. However, aren't you forgetting how much less work it was to put out that small bulletin when it came out regularly? Last year you told me you couldn't print a 32-page bulletin every month. Could you do it 6 or 7 times a year? How about writing it? It's easy to say how things should be when you're not involved in the actual work. I'm sure you'd change your mind if you were.

Thank you for bringing up the problem with the Fandom Directory (I don't have a copy) I xeroxed your comments and mailed them to the Fandom Directory along with a note explaining that reading them had made me feel concerned and I would

like a copy of their C/FO entry so I could correct it.

Why should the club miss any mail because the Fandom Directory paired your name with the Inglewood address? If the Inglewood post office pays that much attention to names being registered with addresses, then it's much fussier than Sierra Vista's. I've gotten letters with my address in English and my name as Ty.=JILX (from a friend) with no problem. I've sometimes addressed her name in Katakana and I believe she still got them.

Thanks for coming up with some more questions about Fred Cain's art contest.

I wish I'd thought of them. (I also wish I'd noticed that he'd subscribed before
I took the trouble to xerox your & my replies to his letter and mailed them to him.)

Your remark [to Dan Davis] about making the C/FO open meeting at the San Diego Comic Con "...more attractive to the C/FOers who'll be there than the video room"

sounds as if you're blaming Dan for the problem. Are you? After all, you've helped preside over those meetings. Don't you have any ideas? Would it help to shut down the video room for an hour so C/FOers won't have to make a choice?

By the way, how do you make sure you don't have an advantage over the rest of us by being able to read all the letters first? Do you write yours before you open ours? (Well, unless we mark the envelopes "for Shop Talk," you couldn't.)

If you realize something's for Shop Talk do you set it aside?

As for talking about people who are non-subscribers, we're already doing that with Harry Hopkins, Kurt Black, and Alex Potter. More importantly, they're being mentioned in terms of the problems that people feel they have with them. Don't you consider that to be the kind of "talking behind someone's back" that was one of the chief arguments against the original Shop Talk's existence? How can these people defend themselves if they don't know what's being said about them? No one says we need to send them the entire issue. We could just send the pages in which they are mentioned (marked, of course, with the writer's name if it doesn't appear on those pages). How do the rest of you feel about this?

Fred, don't you feel there should be some limits on your guarantee that a person who has something to say has a right to get it printed? What about slander? How about an obscene "joke" such as one member spread about another member and his girlfriend at a convention? I don't think that sort of thing should see print. However, it's true that Shop Talk's unofficial status gives you more leeway in allowing rude and/or unsubstantiated remarks to be printed (it's small size doesn't hurt, either). You'd probably be safe in honoring your guarantee no matter what. (I wouldn't count on it.)

I'm afraid I don't see how you can say that a majority vote at an open meeting of the C/FO at a worldcon is enough to make Shop Talk official on p. 5 and then say you would have questioned the attendee of authority to approve Ed Noonchester as the new club treasurer had it been a formal vote on p. 6 and not see the inconsistency in those statements. If you don't think there's any inconsistency, please explain why not.

I've heard that Ed Noonchester not only doesn't want to be the treasurer but that he resents being volunteered in his absence. I certainly can't blame

him for it. (if true) Who volunteered him?
